Commentary:

- Very little difference can be observed between the 2014 figures and those for previous years.
- The response rate in 2014 decreased significantly from that in 2013 (from almost one in three to less than one in four). The most likely explanation for this is that many members had chosen to renew their membership online and had not returned the monitoring form separately.
- The proportion of males has increased slightly over the three years but there are still more than twice as many women as men among respondents.
- Almost half of respondents reported being Christian and another two fifths reported having no religion. Very few people described themselves as belonging any other religion; no respondents reported being Muslim, Sikh or Hindu.
- 87% of respondents described themselves as White British or White Irish.
 Very few people reported being Black, Asian or Mixed Race.
- 11.5% of respondents reported one or more disabilities or long-term health conditions. The nature of these conditions varied considerably.
- Substantial proportions of respondents chose not to answer certain questions: sexual orientation (13%), religion (9.5%), ethnic group (9%), disability (23.5%).

Future changes to the collection of equality monitoring data

- For 2015, the Diversity Working Group proposes to collect equality monitoring data online, using ARA's existing Survey Monkey subscription. This has several advantages:
 - As the use of online membership renewal increases, it should encourage a higher response rate
 - o It simplifies collation and analysis of the statistics
 - o It saves money by avoiding printing costs
 - The size of the survey can be varied without affecting the layout of the form
- The National Archives' Equality and Diversity Co-ordinator has reviewed the form and recommended making some changes. These are:

- We should expand and clarify the opening statement that explains the scope and purpose of equality monitoring
- We should use five-year instead of ten-year age categories
